No formal reports have been completed yet since the Stage 1 and 2 work is currently underway. The assessments are being conducted by Archaeological Research Associates and will continue until mid-August. Only one First Nation find spot has been identified so far. The below description of the find is from our archaeologist. Please let me know if you would like any additional information.

The following discoveries were made:

NAPO21\_Field21\_Point1: The blade portion of a broad chert projectile point was located on the surface of the field. The stem is broken at the side notches and the base is missing. It is possible that this point is of the 'Crawford Knoll' type – a Late Archaic point type dating to the period 1500-500 BC (2500 – 3500 years old). It is made from Onondaga chert – a raw material from the north shore of Lake Erie and parts of New York State. Artifacts made of this chert are found throughout southern and eastern Ontario.

NAPO21\_Field21\_Point2: A section of the blade of a projectile point or knife. It is finely thinned and the blade margins have been delicately worked. Insufficient of the artifact remains to be able to make any determination of age or cultural affiliation although it is undoubtedly of pre-Contact origin. It is made of grey chert – possibly Onondaga – although this is uncertain.

On discovery of each of these items, the surface survey transect interval was reduced from 5 metres to 1 metre and the field surface was carefully scrutinised for any other artifacts for a radius of at least 20 metres. No other artifacts were discovered. Following the intensified surface survey, a 1 metre

test excavation unit was excavated at each location in order to see whether other artifacts were contained within the soil. All soils from the test unit were sifted through 6mm. hardware cloth screen and excavation continued for at least 5cm into sterile subsoil. No further artifacts were recovered. On the basis of this work, it can be reasonably assumed that these artifacts were 'casual loss' artifacts, probably lost or broken be people hunting along the margins of the wetland.

NAPO21\_F21\_FL1 and NAPO21\_F21\_FL2: The small secondary flakes of an unidentified chert were recovered from the surface of the field. These are chips that are detached during making or sharpening chipped stone tools such as arrowheads and knives. As before, the surface survey was intensified in the vicinity of each discovery, but no further artifacts were discovered. The presence of chert flakes sometimes indicates activity areas such as campsites or working areas. In the absence of any other artifacts or evidence of past cultural activity, these do not indicate the presence of an archaeological site. At this point in the archaeological assessment of the Loyalist Solar Project, no additional pre-Contact artifacts have been found.



I acknowledge receipt of your correspondence, received on 24/11/2016 regarding the above project.

As you may be aware, the area in which your project is proposed is situated within the Traditional Territory of Curve Lake First Nation. Also within the Williams Treaties Territory and is the subject of a claim under Canada's Specific Claims Policy. We strongly suggest that you provide Karry Sandy-Mackenzie, Williams Treaty First Nation Claims Coordinator, 8 Creswick Court, Barrie, ON L4M 2S7, with a copy of your proposal as your obligation to consult to also extend to the other First Nations of the Williams Treaties.

Curve Lake First Nation is requiring a File Fee for this project in the amount of \$250.00. Also due to the size and scale of this solar project we will be requesting a \$5000 Review of Large Materials Fee as outlined in the Consultation and Accommodation Standards, a copy of which is enclosed with this letter. These Fees include project updates as well as review of standard materials, project overviews, and review of large materials; reports and detailed applications.

Based on the information that you have provided us with respect to Loyalist Solar Project Curve Lake First Nation requires a Special Consultation Framework for this project. Information on this Framework can be found on page 9 of the Consultation and Accommodation Standards.

In order to assist us in providing you with timely input, it would be appreciated if you could provide a summary statement indicating how the project will address the following areas that are of concern to our First Nation within our Traditional and Treaty Territory: possible environmental impact to our drinking water, endangerment to fish and wild game, impact on Aboriginal heritage and cultural values, and to endangered species, lands, savannas etc.

After the information is reviewed it is expected that you or a representative will be in contact to make arrangements to discuss this matter in more detail and possibly set up a date and time to meet with Curve Lake First Nation in person.

Although we have not conducted exhaustive research nor have we the resources to do so, Curve Lake First Nation Council is not currently aware of burial or archaeological sites in your proposed area. Please note, that we have particular concern for the remains of our ancestors. Should excavation unearth bones, remains or other such evidence of a native burial site or any other Archaeological findings, we must be notified without delay. In the case of a burial site, Council reminds you of your obligations under the *Cemeteries Act* to notify the nearest First Nation Government or other community of Aboriginal people which is willing to act as a representative an whose members have a close cultural affinity to the interred person. As I am sure you are aware, the regulations further state that the representative is needed before the remains and associated artifacts can be removed. Should such a find occur, we request that you contact our First Nation immediately.

Curve Lake First Nation also has available, trained Archaeological Liaisons who are able to actively participate in the archaeological assessment process as a member of a field crew, the cost of which will be borne by the proponent.

Although we may not always have representation at all stakeholders meetings, it is our wish to be kept appraised throughout all phases of this project.

In your letter, you note the importance of copying all correspondence to Karry Sandy-Mackenzie, the Williams Treaty First Nation Claims Coordinator. I can confirm that Karry Sandy-Mackenzie has been provided with correspondence to date and going forward we will continue to provide Project-related information.

Thank you for providing the Consultation and Accommodation Standards. In regards to the \$250 File Fee and the \$5,000 Review of Large Materials Fee, Loyalist Solar LP understands the importance of determining whether or not the Project has the potential to adversely affect the rights and interests of Curve Lake First Nation and agrees to provide these fees.

As requested, a summary statement will be developed which will address potential impacts to drinking water, fish and wild game, endangered species, lands, savannas, Aboriginal heritage and cultural values. In addition to the summary statement, the Renewable Energy Application reports including the Natural Heritage Assessment, will provide valuable information in regards to these concerns and we are available to respond to any inquiries you may have about these reports. As you are aware, the Mohawks of the Bay of Quinte are a partner in the Project and have been involved in the review of potential environmental impacts and mitigations.

Also as partners, the Mohawks of the Bay of Quinte have been involved in all aspects of the archeological assessments undertaken to date. A monitor has been on site during the field season last year. The Stage 1 and Stage 2 Archaeological Assessments were provided to Curve Lake First Nation in November 2016. Loyalist Solar LP can certainly provide additional updates as the Stage 3 and 4 archaeological work is undertaken in 2017. As requested, Curve Lake First Nation will be immediately notified if any evidence of remains or a burial site are found.

We look forward to further correspondence in the near future.
