ADDENDUM TO: The Heritage and Tourism Impact Assessment for Bow Lake Wind Farm Phase 1 and Phase 2 Revised February 2012, prepared by Commonwealth Historic Resource Management and TCI Management Consultants

The following responds to the updated requirements of the REA Section 23 (2.1a), which requires *A person who is subject to subsection (1) shall submit a heritage assessment report to the Ministry of Tourism, Culture and Sport, consisting of,*

(a) a summary of the qualifications and experience of the persons who conducted the assessment and prepared the report;

John J. Stewart, B.L.A., O.A.L.A., C.S.L.A., a principal of Commonwealth, Stewart is a specialist in the planning and design of cultural resources, building conservation, and cultural heritage landscape assessments. A graduate of University of Guelph, he received additional training at Cornell University (USA) and Oxford University (UK) and holds a diploma in the Conservation of Monuments from Parks Canada, where he worked as Head, Restoration Services Landscape Section. Before Commonwealth's formation, Stewart served for four years as the first director of Heritage Canada's Main Street Program, and in this capacity was responsible for initiating, developing, and ongoing supervision of downtown revitalization projects across the country. Under Stewart's direction, the firm designed and managed the construction of the Queen Elizabeth II Botanic Garden in the Cayman Islands, prepared a Heritage Conservation Plan for the Ottawa Botanic Garden on the Central Experimental Farm. He has undertaken numerous heritage impact assessments including a strategy for Allan Gardens (Toronto) as well as a conservation strategy for the Mackenzie King Estate near Ottawa, and Lansdowne Park revitalization in Ottawa. Each required defining the site's cultural values, assessing development and mitigation strategies. He has served as the Canadian representative of the Historic Landscapes and Gardens Committee of ICOMOS and the International Federation of Landscape Architects 1974-1980. The fall/winter 2012 volume 14 no. 4 Issue of *Landscapes/Paysage* *time and place* features an interview with Stewart and provides an insight into 35 years of practicing as a heritage landscape consultant.
