ATCO Electric Ltd., pursuant to Permit and Licence U2012-165,¹ is the operator of the 144-kilovolt (kV) Transmission Line 7L128 from Coyote Lake 963S Substation to Michichi Creek 802S Substation in the Drumheller area (the transmission line).

ATCO, by Application 27008-A002, registered on November 30, 2021, applied to the Alberta Utilities Commission for approval to alter and operate the transmission line. The alteration consists of modifying the transmission line to accommodate a T-tap connection to Transmission Line 7LA128.

The Commission, pursuant to sections 14, 15 and 19 of the *Hydro and Electric Energy Act*, approved the application in Decision 27008-D01-2022² and granted to ATCO a permit to alter and a licence to operate the transmission line, subject to the provisions of the *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders made under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

- 1. The route of the transmission line shall be as shown on Appendix A and as described in Application 1607188.
- 2. Permanent access trails shall be constructed at the locations listed in Appendix B and as described in Application 1607188 and shall be considered to be part of the transmission line right-of-way.
- 3. Specifications of the transmission line shall include the following:
 - (a) The transmission line shall be designed, built for and operated at a nominal voltage of 144 kV.
 - (b) The structures shall be constructed of materials as specified in the application and other previous approvals pertaining to the transmission line.

- (c) Other aspects of the alteration shall be constructed as more particularly described in the application and other previous approvals pertaining to the transmission line.
- 4. ATCO shall file with the Commission within 30 days of completing the transmission line alteration, the energization certificate(s) for the transmission line issued by the Alberta Electric System Operator and/or by ATCO, to confirm that the transmission line alteration has been completed and the transmission line is being operated in accordance with the provisions of this permit and licence.
- 5. Unless otherwise authorized by the Commission, the transmission line alteration shall be completed by September 1, 2022, or a later date of March 1, 2023 subject to ATCO filing an approval by the Alberta Electric System Operator of a change proposal for the later in-service date.

Permit and Licence U2012-165 is rescinded.



The Commission may, no later than 60 days of the date of this permit and licence and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected permit and licence on its website.
