Subject: Two Rivers Wind Energy Project, Carbon County, Wyoming

Two Rivers Wind LLC, is initiating local permit applications required to construct and operate Two Rivers wind project (“Two Rivers” or the “Project”) on a private ranch and BLM lands in Carbon County, Wyoming.

The Project will include up to 60 turbines, with a total nameplate capacity of 280 megawatts (MW) sited on 15,657 acres. The final number of turbines and the generation capacity of each has not yet been finalized for the project. The Project will be situated on the Two Rivers Ranch in Carbon County north of Highway 30 and the Town of Medicine Bow.

Two Rivers anticipate construction to begin on the Project in 2023, with commercial operations expected in early 2025. A preliminary site plan for the project is enclosed. Final project design is still underway, and locations of proposed facilities are subject to be modified. Additional project information is available at: www.blueearthrenewables.com/tworivers/.

In-person meetings were held with counties, towns, and state agencies in 2018, 2019, 2021 and 2022 to introduce the Project and establish permitting expectations and timelines.

The Wyoming Department of Environmental Quality Industrial Siting Division issued a permit for the Project on November 19, 2019. Carbon County also determined that a Conditional Use Permit is required to construct and operate a commercial Wind Energy Conversion System (WECS) per their current Zoning Resolutions. Two Rivers is preparing a Conditional Use Permit Application for submission to Carbon County in early 2023.

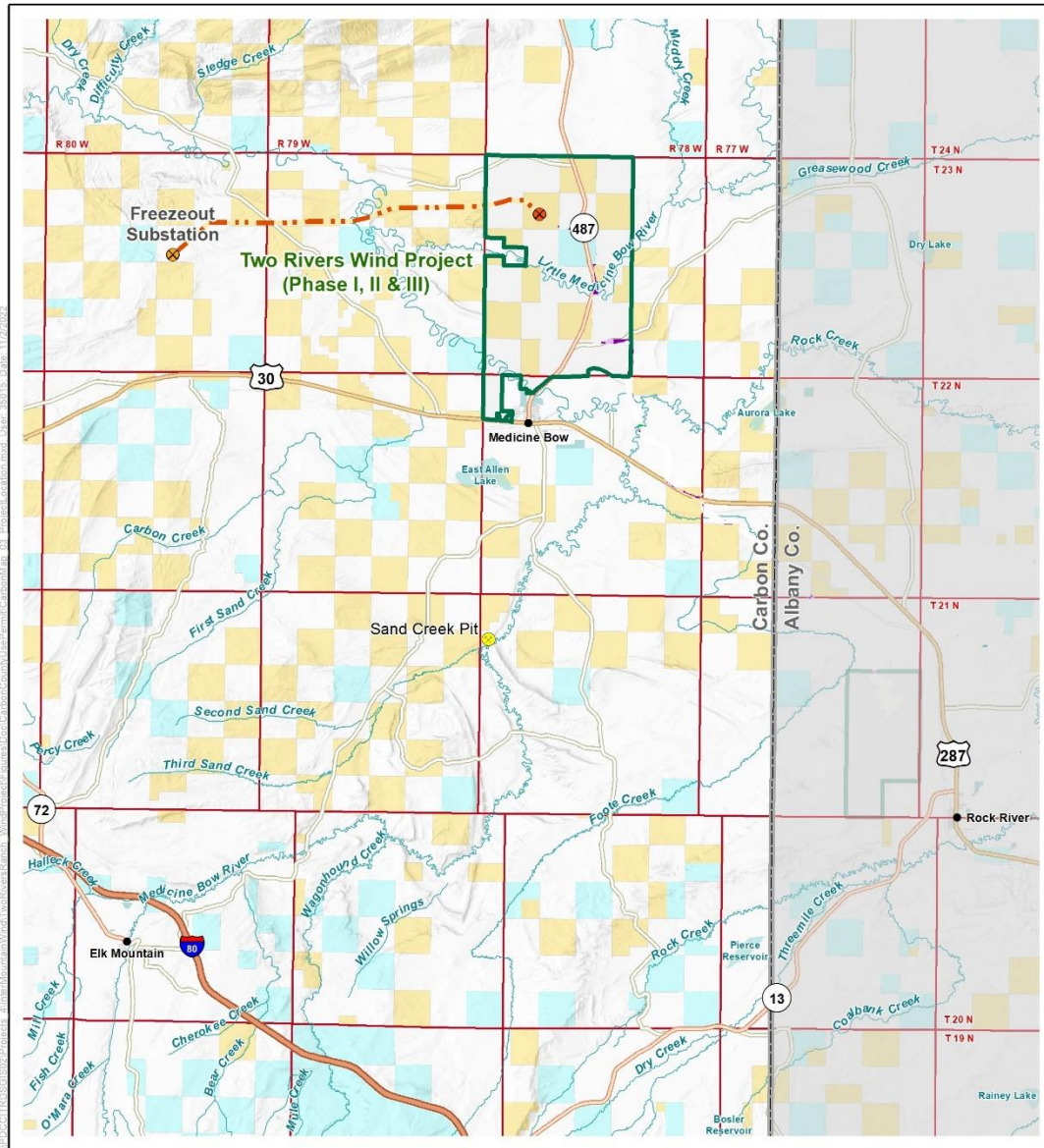

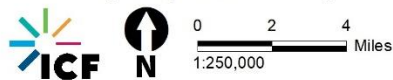

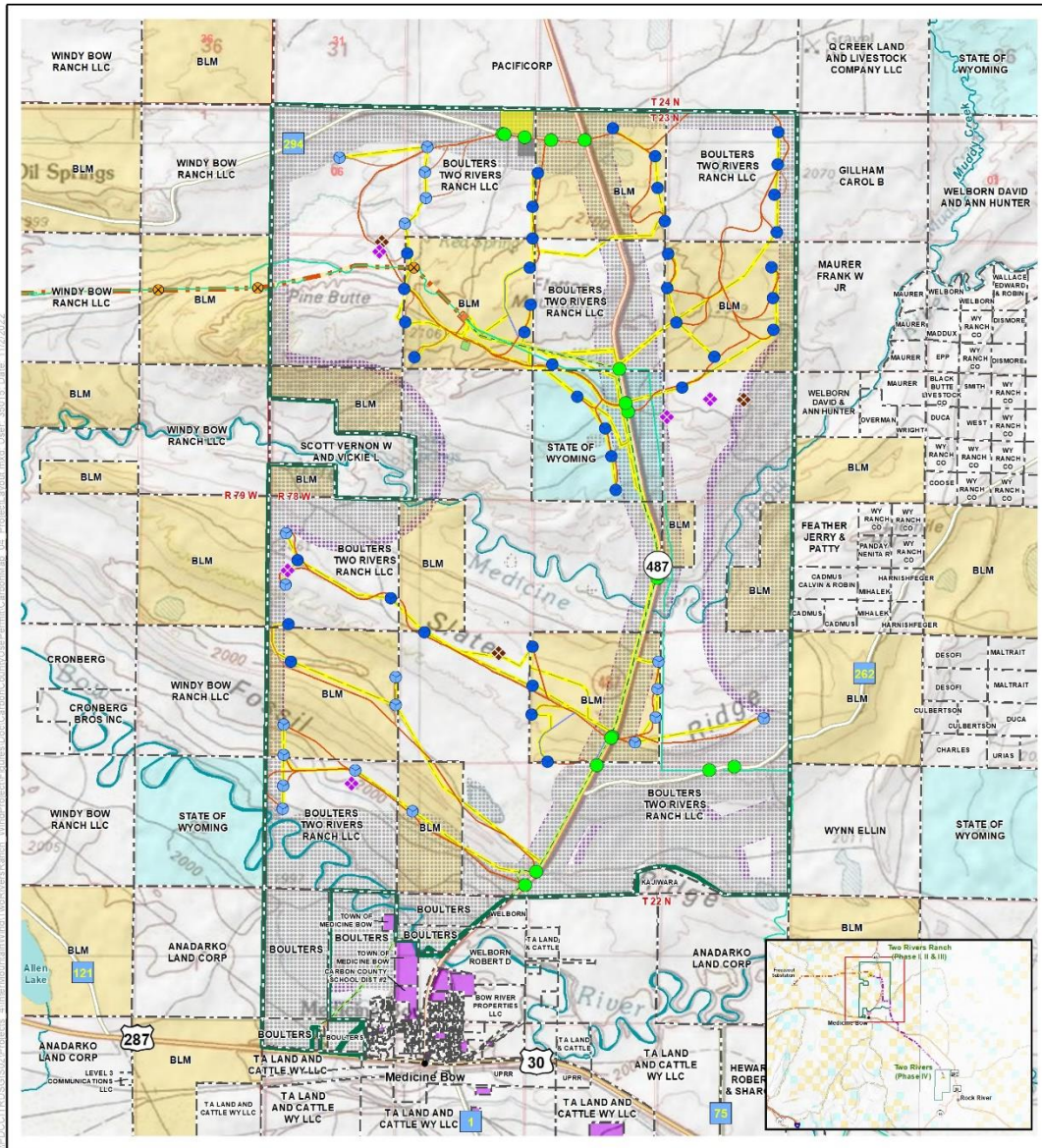

Dear Landowner,

Two Rivers Wind LLC and Lucky Star Wind LLC, both wholly owned subsidiaries of BluEarth Renewables US LLC, are initiating local and state permit applications required to construct and operate the Two Rivers and Lucky Star Wind Projects on three private ranches in Carbon and Albany Counties, Wyoming.

The Two Rivers Wind Project comprises development of four wind power generation facilities with a combined capacity of up to 280 megawatts (MW) on 19,500 acres. Two Rivers I, II, and III will be situated on the Two Rivers Ranch in Carbon County north of Highway 30 and the Town of Medicine Bow. Two Rivers IV will be situated on a portion of the Medicine Bow River Ranch in Albany County south of Highway 30 and west of the Town of Rock River.

The Lucky Star Wind Project comprises development of a wind power generation facility with a capacity of up to 500 MW on 78,000 acres on two private ranches. The Lookout Ranch in Albany County is located south of the Town of Rock River and southwest of Highway 30. The Medicine Bow River Ranch in both Carbon and Albany Counties is located southeast of the Town of Medicine Bow and south of Highway 30.

The number and generation capacity of wind turbine generators has not yet been finalized for either project. Preliminary site plans for the Two Rivers Wind Project includes up to 80 wind turbines on Two Rivers Ranch and up to 20 wind turbines on Medicine Bow River Ranch. Preliminary site plans for the Lucky Star Wind Project includes up to 100 wind turbines on Medicine Bow River Ranch and up to 200 wind turbines on Lookout Ranch.

Two Rivers I, II and III is anticipated to be constructed first, beginning in 2019 while Two Rivers IV is anticipated to commence construction in 2020. Commercial operations for the Two Rivers Wind Project is expected in late 2020. Construction for Lucky Star is anticipated to begin in 2020 and continue through 2022, with operations scheduled to commence in late 2022. Project fact sheets and preliminary site plans for both projects are enclosed. Final Project design is still underway, and locations of proposed facilities are likely to change. Additional Project information is available at the following websites: www.blueearthrenewables.com/tworivers/ and www.blueearthrenewables.com/luckystar/.

In-person meetings were held with counties, towns, and state agencies in July and September 2018 to introduce the wind projects and establish permitting expectations. The Wyoming Department of Environmental Quality Industrial Siting Division determined that a permit is needed from the Wyoming Industrial Siting Council (ISC) as both projects exceed the current statutory jurisdictional capital cost threshold of \$211.1 million and/or a commercial wind energy facility consisting of thirty (30) or more turbines (W.S. § 35-12-102). Both Carbon and Albany Counties determined that Conditional Use Permits are required to construct and operate a commercial Wind Energy Conversion System (WECS) per their current Zoning Resolutions.

We have initiated preparation of the permit applications. Conditional Use Permit Applications are planned for submittal to Carbon and Albany Counties in early 2019. The permit application submittal to the Industrial Siting Council is planned for early 2019 with a public hearing tentatively planned in mid-2019.

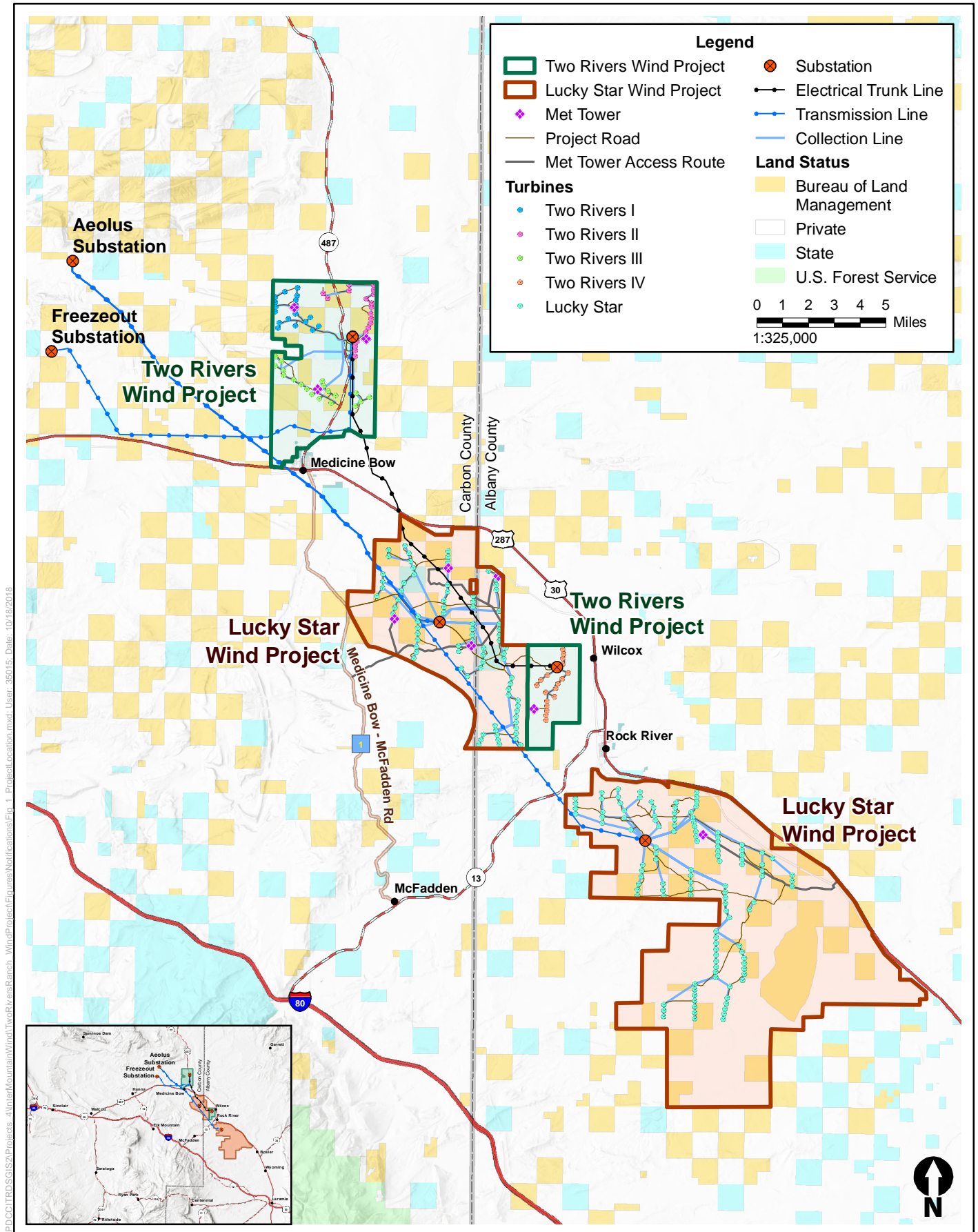

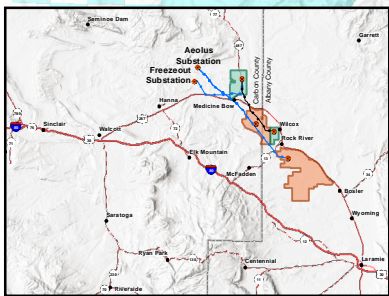
